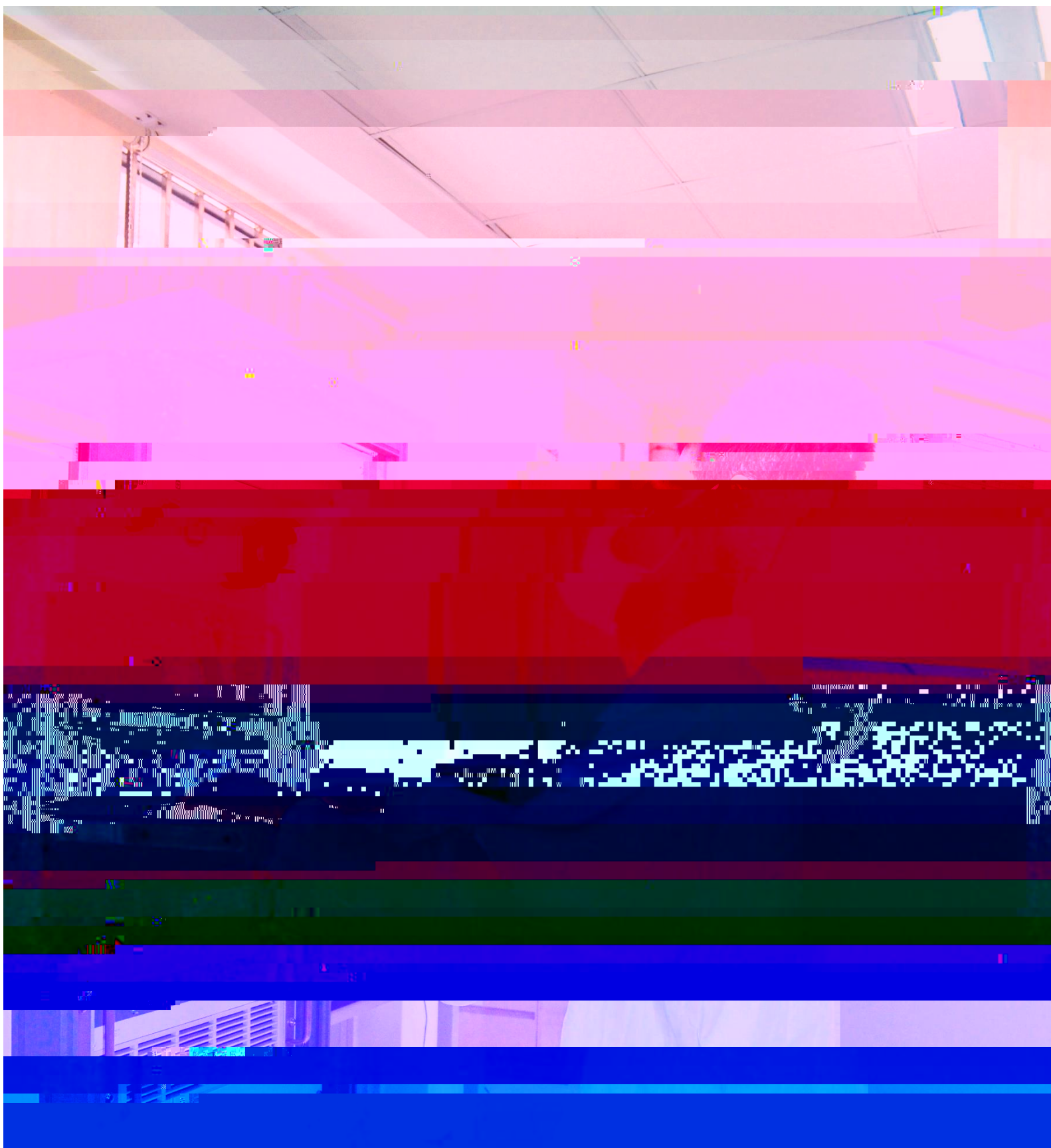

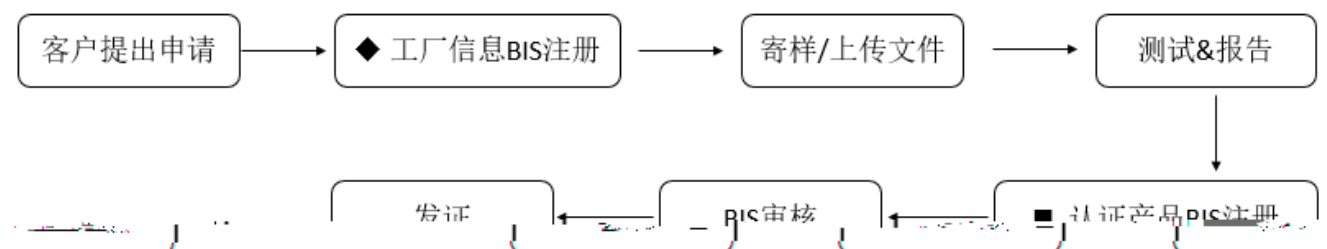

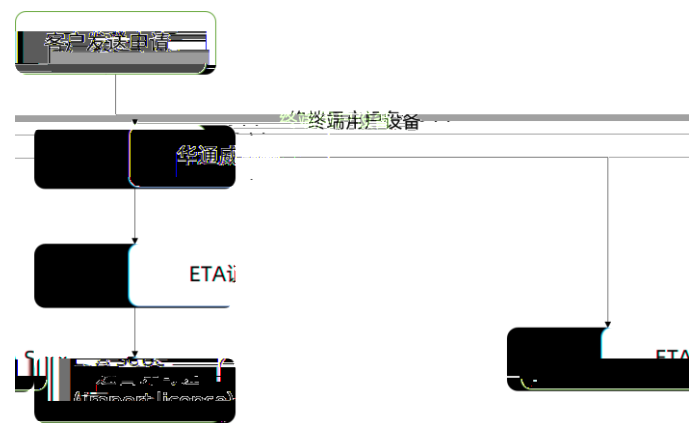

OFFICE MEMORANDUM

Subject: ETA through self-declaration for certain categories of Wireless Equipment in license exempt bands.

This is with reference to Equipment Type Approval (ETA) requirement for certain categories of wireless equipment operating in license exempt bands with low transmission power which are exempted from import licensing requirement as per the import policy of DGFT.

2. ETA through self-declaration is permitted for commercial finished products such as mobile computers viz. as mobile handsets, smart phones, electronic notepads, laptops, Smart watches, Short Range Devices including accessories, microphones, speakers, headphones, earphones, printers, scanners, etc., operating in a licensed exemption band as permitted in India. A self-declaration from importer / authorized Indian representative may be treated as sufficient evidence to process such clearance by the Customs and Central Excise Authorities. (self-declaration format is enclosed).

3. Import license requirements are as regulated by the Export and Import (EXIM) Policy of DGFT.
